#### **PTIN Information Directory Request**

#### **PTIN Directories**

Third party, for profit organizations have obtained the PTIN list under the *Freedom of Information Act* (FOIA) and created an online directory of tax professionals. The IRS is aware of these types of directories and released a statement that the information was obtained legally and there is nothing that they can do to prevent them from creating these directories. The information that they are given includes names, addresses and phone numbers, but not actual PTINs. We want to warn you not to provide these websites with your PTIN, as that may lead to fraudulent use of PTINs. \* Reprinted from NATP Taxpro Weekly, September 20, 2012.

The following is a brief outline of Mrs. Lorene's work history and accomplishments during her career.


